Consultation opens on children not attending mainstream schools

The Department for Education is seeking views on proposed legislation to establish a register maintained by local authorities of children not attending mainstream schools, together with associated duties on parents and the proprietors of certain educational settings.

New Blue Badge rules in England to come into force on 30 August

Last year the government announced its intention to expand the blue badge rules in England to make it easier for people with hidden disabilities such as autism to qualify. After a lengthy delay the government has now published regulations confirming that these [new rules will start to apply from the 30 August 2019](#).

DWP under investigation for recovering overpaid Carer's Allowance

MPs on the Work and Pensions select committee have started investigating the Department for Work and Pensions' decision to recover £150 million in overpaid Carer's Allowance from 80,000 carers. Contact, the disability charity, are calling on the government to [drop](#) its pursuit of carers who have been overpaid mostly due to innocent mistakes and the department's own administration issues.

End Child Poverty report finds fastest rises in poverty hit poorest areas

New findings published by End Child Poverty reveal that [child poverty is becoming "the new normal"](#) in parts of Britain. This echoes Contact's own [Counting the Costs research](#), which found that there has been a sharp rise in disabled children going without essentials such as specialist therapies and equipment at a time when financial support for families is being drastically cut.

Carer's allowance earnings limit rises to £123 per week

Carer's Allowance is the main benefit for carers. You can still get it even if you are working, so long as your earnings are no more than a weekly amount known as 'the earnings limit'. From 1 April the earnings limit went up to £123 per week.

New Universal Credit fact sheet

Contact has produced a new [factsheet](#) on claiming Universal Credit for a young disabled person. This free publication explains when a young person can claim Universal Credit in their own right and the impact this might have on any payments that their parents receive for them as a dependent. It also sets out the particular difficulties that young people in education face in trying to claim Universal Credit.

A review into the placement of children in Residential Schools called "Good Intentions, Good Enough?"

Dame Christine Lenehan undertook a review into the placement of children in Residential Schools called "Good Intentions, Good Enough?". The report made a number of recommendations including the setting up of a SEND System Leadership Board with an independent chair. Ministers from the Department for Education (DfE) and Department of Health and Social Care (DHSC) further agreed to meet with stakeholders twice a year to hear directly the concerns of the sector. NNPCF's State of the Nation Report 2019

NNPCF has refreshed its [report](#) looking at the State of the nation, reflecting on the feedback received around the experiences of families and carers of children and young people with special educational needs and disabilities (SEND) around the country. It focuses on the experiences a year after the end of the of the implementation period for the Children and Families Act (over the last 12 months since the last report was published).

Damien Hinds speech to National Association of Headteachers

On the 3rd May the Secretary of State for Education [spoke](#) to the National Association of Headteachers (NAHT). In his speech, he focused on the funding challenges being faced by schools, particularly the support for children with SEND. For the last two years, local parent carer forums have been expressing concerns about the level of funding for SEND provision. The NNPCF have shared these with the Department for Education calling for appropriate funding to enable the legal requirements and ambitions of the 2014 reforms to be realised.

LeDeR Report

The learning from death reviews (LeDeR) programme is about stopping people with a learning disability dying younger than other people. The third annual report about the LeDeR programme has now been published by Bristol University. You can read the report, including the easy read version, [here](#)

Physically Disabled People and Homelessness

New government figures have shown that the number of physically disabled people experiencing homelessness has risen by more than three quarters in a 10 year period. This is partly due to a serious lack of accessible housing. More [here](#)

LOCAL SEND NEWS

Free Schools Bid Update

Bromley has successfully bid to be part of the DfE's new wave of special free schools and alternative provision. They have moved into the second phase of the wave, which is a bidding process for interested Academy Trusts to bid to provide the school. The process is led by the DfE who will choose the successful Trust.

Their proposal is to establish a 54 space Key Stage 2 school at the Hawes Down Centre. The school will be for children with ASD and associated learning difficulties (including anxiety and/or behaviours that challenge). A diagnosis of ASD will not be required, but all children will have a complexity of need relating to speech, language and communication, emotional wellbeing and behaviours that challenge.

Local Area SEND Inspection

The LB Bromley, Bromley Clinical Commissioning group and wider partners are currently preparing for the Local Area SEND Inspection which will be carried out jointly by Ofsted and the Care Quality Commission (CQC). This is an inspection of

the Local Area.

The purpose of the area inspections is to look at how the changes brought in by the 2014 SEND reforms have been implemented. The inspectors will look across education, health and social opportunities. If they feel not enough progress has been made they may issue a written statement of action.
