If possible, systems should be adjusted to full fresh air or, if not, then systems should be operated as normal as long as they are within a single room and supplemented by an outdoor air supply.</li> <li>Natural ventilation – opening windows (in cooler weather windows should be opened just enough to provide constant background ventilation and opened more fully during breaks to purge the air in the space). Opening internal doors can also assist with creating a throughput of air. 	For pupils who have complex needs or who need close contact care an individual risk assessment will be completed and reviewed regularly to take into account government advice. This will be shared with and agreed by parents and carers.		
	Pupils to be taught, as far as is possible, to maintain distance and not touch peers or staff.		
	Seat pupils side by side and facing forwards, rather than face to face or side on. For younger children in nursery, EYFS, Y1 or those with complex needs, consider space to move around for less formal seating with less furniture.  Use outdoor space, when available, as much as possible.		
	Remove all unnecessary furniture if there is a space to place this.		
	For individual and very frequently used equipment, such as pencils and pens, staff and pupils will have their own items that are not shared. Each pupil will have their own zip folder of equipment that is kept in school.		
	Classroom based resources, such as books and games, used and shared within the bubble will be cleaned regularly.

	Movement around the school site kept to a minimum.  When staff are moving around the school or in communal areas, they will need to wear a face covering.		
	Signage will be clear around the school to keep social distancing in place.

Visitors to the school site –only essential contractors to deal with urgent works.	Supply teachers, peripatetic teachers and/or other temporary staff will ensure they minimise contact and maintain as much distance as possible from other staff and pupils. Staff who are pregnant.	An individual risk assessment will be completed for all staff who are pregnant, are breast feeding or who have given birth within the last 6 months. 	If someone in a class or group that has been asked to self-isolate develops symptoms themselves within their 10-day isolation period they should follow 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection'. They should get a test, and:  • if the test delivers a negative result, they must remain in isolation for the remainder of the 10-day isolation period.
